# What Can an AAT Bookkeeper Do?



An AAT Bookkeeper is qualified to provide bookkeeping services to support businesses of all sizes with accurate financial records ensuring that their accounts are up-to-date.

A bookkeeper helps businesses stay in complete control of their finances - they deal with day-to-day finance tasks such as data entry, VAT returns and payroll, and can prepare anything up to trial balance. The types of services typically carried out by a bookkeeper include:

- Purchase orders and invoicing
- Sales accounting and credit control
- Cash and banking admin
- Data processing
- Payroll accounting
- Using data to prepare financial statements

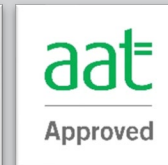
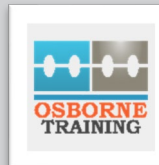

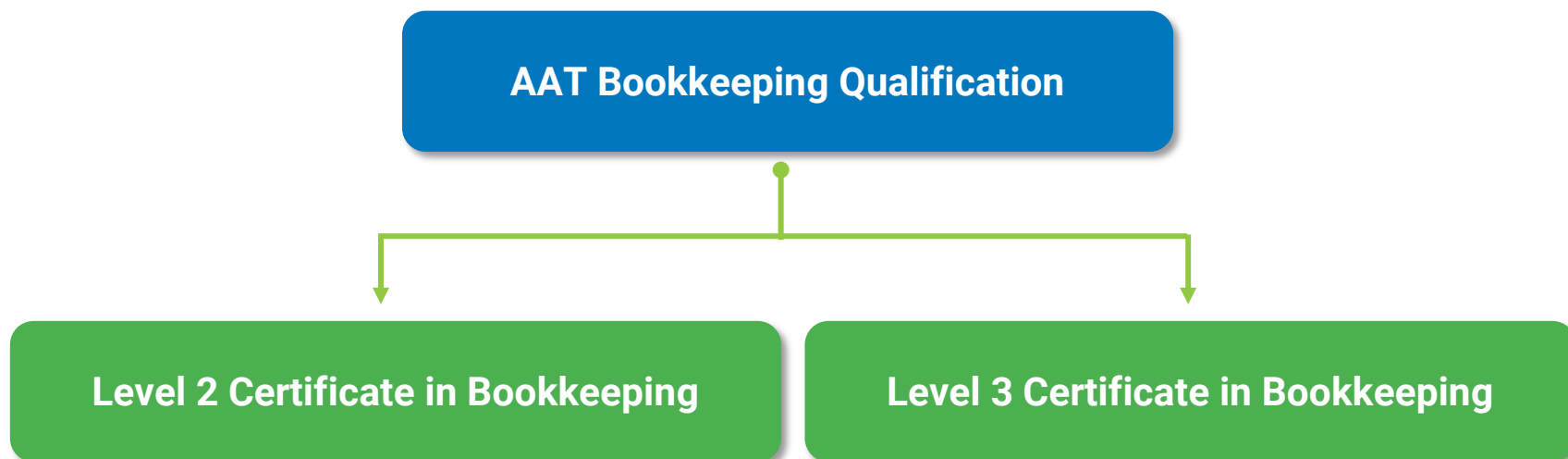

# AAT Level 2 Certificate in Bookkeeping - in Detail



- ✓ This level will help you develop your skills in double entry bookkeeping and give you an understanding of management and administrative processes.
- ✓ You'll develop practical accountancy skills in the double-entry bookkeeping systems and learn to make entries in appropriate books and ledgers, and calculate sales invoices and credit notes.
- ✓ You will be awarded with AAT Level 2 Certificate in Bookkeeping from Association of Accounting Technicians (AAT), once you have passed all the exams.
- ✓ Once you finish Level 2 Bookkeeping, you may progress towards Level 3, or alternatively you can study both Level 2 & Level 3 together through the fast-track option.

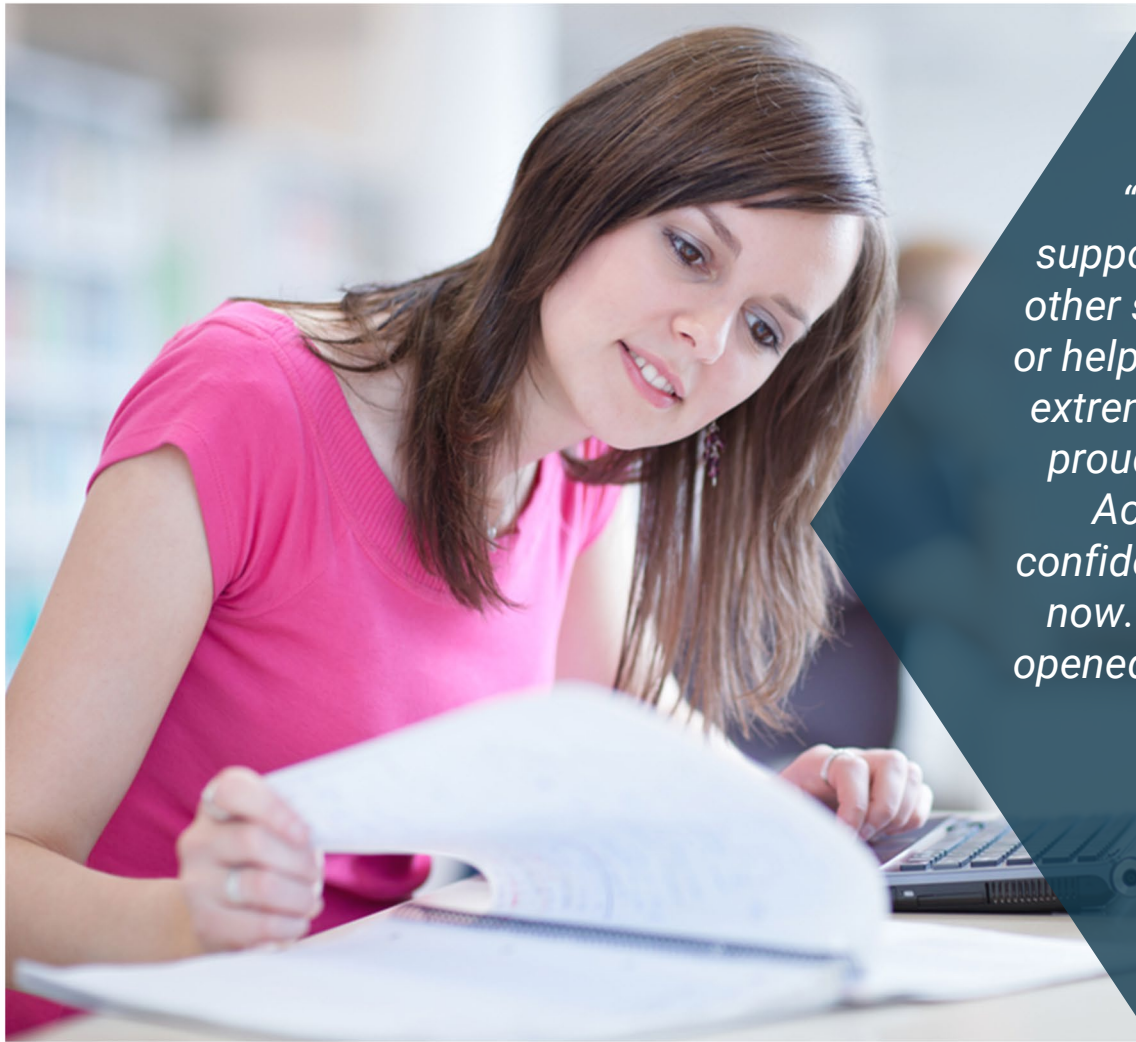
